Award Qualifications and Requirements**

Following is a list of qualifications and requirements an applicant must have to be successful in securing an award from the Knights of Columbus Council No. 4868.

**QUALIFICATIONS**

1. Senior in High School, residing in the State of Texas and a member of the St. Paul's Catholic Church, Smithville, Texas
2. Membership by living or deceased Father or living Grandfather (Step Relations allowed) in the Smithville Knights of Columbus Council No. 4868 This member must be in good standing. In the event the relation to deceased Father meets this requirement, the member must have been in good standing at the time of his death. Deceased Grandfather not eligible for applicant.
3. Must be a practicing Catholic
4. Must be involved in Past/Present parish activities
5. Must be attending and active in High School level Religious Education Classes.

**REQUIREMENTS**

1. Submit Official Application including a wallet-sized photo
2. Letter of Introduction including specific list of community and church involvement
3. Note of recommendation from high school level, religious education instructor with record of attendance
4. Essay not to exceed 500 words on "What My Catholic Faith Means to Me".
5. One letters of recommendation from public or private school educators, who have instructed the applicant.
6. Verification of enrollment in an accredited college, university or trade school.

**NOTES**

1. The full application must be received by 3:00 p.m., April 30, 2021
2. If any of the 6 required items (noted above) is not provided, the application will be returned and will not be scored for an award.
3. Official award shall be given at an open meeting and winner(s) name will be recorded on a plaque located in the K of C hall. The date and time to be announced later.
4. The award shall be for "one-time" only. Subsequent applications by previous winners shall not be considered.

The awards granted (dollar amount) would be based on applicants score and available funds at the time of selection. The Award Committee will score the applications. In the event an applicant is the child of a voting committee member, a replacement will be appointed. The Award Committee will present recommendations to Council 4868 and Council will vote on awards.
